WHEREAS in terms of Section 15 (1) of the NCTE Act, 1993 **BHAGWATI COLLEGE OF EDUCATION NH-58, SIWAYA,, ROORKEE ROAD,, MEERUT-250001, , UTTAR PRADESH** had submitted an application (Code No. APN03395) to the Northern Regional Committee of National Council for Teacher Education for grant of recognition / permission for an additional intake of 100 in **BED** Course of 1 year duration.

2. AND WHEREAS on scrutiny of the application submitted by the institution, the documents attached therewith the Affidavit and the inputs received from the Visiting Team in the form of report and videography, the Committee is satisfied that the institution / society fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the Secondary Teacher Education Education including the Norms and Standards for the Secondary Teacher Education programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory etc for running the programme and has selected / appointed duly qualified teaching staff as per NCTE norms.

3. Now, therefore, in exercise of the powers vested under Section 15(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to **BHAGWATI COLLEGE OF EDUCATION NH-58, SIWAYA,, ROORKEE ROAD,, MEERUT-250001, , UTTAR PRADESH** for an additional intake of 100 students in **BED** course of 1 year duration and thereby making the annual intake of 100 students under clause 7 (12) of NCTE Regulation dated 13th Jan 06 subject to fulfillment of the following :-

- (i). The institution shall within one month of the receipt of Recognition order, convert the Endowment Fund account into a Joint Account to be operated along with an official of the Regional Committee.
- (ii) The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, as amended from time to time.
4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government, etc, wherever applicable.

5. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the Statement of Annual Accounts duly audited by a Chartered Accountant.
6. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act, 1993.
7. The institution shall maintain and update the Website as per provisions of NCTE Regulations.

2. The NRC at its 116th meeting held on 20th - 22nd April 2007 at NCTE, Jaipur considered application of the institution including in the agenda for the meeting and after careful examination of relevant documents, Visiting Team Reports, Video Recording, Original Files etc. as per the case found the institution fit for grant of recognition of the course and intake mentioned against their names under 7(11) of the regulations **subject to the condition of appointment of qualified staff through duly constituted selection committee as per the norms of NCTE/State Govt./Affiliating University/Body given effect before the commencement of the course etc.**


3. In view of the above, the committee decided to issue a letter of conditional recognition to the above institution with the advice to remove the deficiencies shown against their names in column No. 5 above and furnish compliance within 30 days from the date of issue of this letter.

4. The institution shall undertake appointment of the staff by a duly constituted selected committee and ensure selection of candidates possessing qualifications as prescribed under rules. (Appointment shall be made on the basis of recommendations of the Selection Committee constituted as per the policy of the UGC/Affiliating University)

5. Attention of the institution concerned is also drawn to section 7(12) of NCTE Regulations dt. 13.01.2006, which reads as **"The institutions concerned, after appointing the requisite faculty / staff, shall put the information on its official website and also formally inform the Regional Committee concerned. The Regional Committee concerned shall then issue a formal unconditional recognition order"**. Compliance with the requirements shall be submitted on a Sworn affidavit and annexures thereto for issue of unconditional recognition order. Until then the institution shall not admit students to the course.

6. Therefore, the institutions are hereby issued a letter of conditional recognition for further necessary action to submit requisite compliance and take steps as per the NCTE Rules and Regulations before the commencement of the session.

ORDER

WHEREAS, in exercise of the powers conferred by sub-section (2) of Section 32 of the National Council for Teacher Education Act, 1993 (73 of 1993) and in supersession of the National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

2. AND WHEREAS, the recognition was granted by NRC to Bhagwati College of Education, NH-58, Siwaya, Roorkee Road, District – Meerut-250001, State – Uttar Pradesh for B.Ed. Course vide order No. F.NRC/NCTE/F-3/UP-1083/3765-3773 dated 08.07.2004 with an annual intake of 100 seats with effect from the academic session 2004-2005 and B.Ed. Additional Intake vide order No. F.NRC/NCTE/F-3/UP-2300/2007/19869-76 dated 28.06.2007 with an annual intake of 100 seats.

3. AND WHEREAS, the institution Bhagwati College of Education, NH-58, Siwaya, Roorkee Road, District – Meerut-250001, State – Uttar Pradesh has by affidavit consented to come under New Regulations and sought for two basic units in B.Ed., which require additional facilities.

4. AND WHEREAS, it has been decided to permit the institution to have two basic units of 50 students each subject to the institution fulfilling following conditions namely.

- (i) The institution shall create additional facilities that include (a) additional built-up-area, (b) additional infrastructure, (c) additional funds, (d) adhere to staff norms as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
- (ii) The application-Institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC) and the Building Plan (BP) in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting Team at the time of inspection.
- (iii) The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these condition by 20 February, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
- (iv) In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/ Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted alongwith the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such institution shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Northern Regional Committee in respect of Section 17/complaint cases etc.

5. Now therefore, in the light of the above, the Northern Regional Committee, NCTE hereby issues the revised Recognition Order to Bhagwati College of Education, NH-58, Siwaya, Roorkee Road, District – Meerut-250001, State – Uttar Pradesh for conducting B.Ed. programme of two years duration with an annual intake of 100 for two basic units of 50 students each from the academic session 2015-2016 subject to fulfillment of the conditions mentioned herein before 31.10.2015.

6. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, State Government etc. as applicable. The affiliating body (University/State Govt.) shall also be required to verify the authenticity of the land & building documents as well as appointment of requisite teaching & non-teaching staff as per provisions of the NCTE Regulations, 2014 by the concerned institution before grant of affiliation to an institution.

7. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

8. The institution shall maintain & update its website as per provisions of NCTE Regulations and always display following as mandatory disclosure.

- (a) Sanctioned programmes along with annual intake in the institution.
- (b) Name of the faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- (c) Name of faculty members who left or joined during the last quarter.
- (d) Names of students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
- (e) Fee charged from students.
- (f) Available infrastructural facilities.
- (g) Facilities added during the last quarter.
- (h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- (i) The affidavit with enclosure submitted along with application.
- (j) The institution shall be free to post additional relevant information, if it so desires.
- (k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If the institution Contravenes any the above conditions or the provision of the NCTE Act, Rules, Regulations and Orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act.
